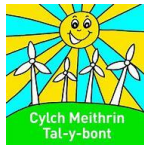

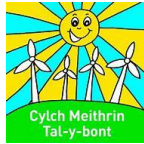

This is a play group which gives children the chance to socialise with other children of the same age whilst developing in every way through the medium of Welsh. The aim of the Mudiad Meithrin is to provide every young child in Wales with an opportunity to benefit from early years services and experiences through the medium of Welsh.

Principles

Mudiad Meithrin believes that:-

- Acquiring the Welsh language is of an advantage to children
- Every child should have an equal opportunity to access Welsh medium services in the early years within easy reach of their home
- Continuity in Welsh medium education is essential for every child attending our provision
- Play is fundamental to the physical, emotional, linguistic, social and intellectual development of children
- Children, whatever their needs, benefit from good quality early years experiences
- Children's rights in accordance with the United Nations Convention on the Rights of the Child and the Children's Act 1989, are very important.
- Actively promoting health, well-being and sustainability using a range of activities, resources and experiences within the preschool setting and community by working with local and national initiatives, thus resulting in healthy, active and happy children, families and staff.
- We have a variety of resources, toys, books, paint, clay, water play, sand, bikes, slides, swings, building blocks and a lot more.

Cylch Meithrin Tal-y-bont Statement of Values

Inclusion

Rydym yn rhoi cyfle i bob plentyn beth bynnag a'u anghenion. Rydym yn gweithio llawer o cydweithwyr ac asiantaethau fel Mudiad ac Awdurdod Addysg Ceredigion I rhoi cymorth a chefnogaeth I'r plentyn a'r rhieni fel yr angen.

We aim to make sure that every child has every opportunity possible whatever their needs are. The Cylch works with multi-agencies and Ceredigion Education Authority to support every child and their families as they may need.

Amddiffyn Plant/Child Protection

Rydym yn dilyn polisi a gweithdrefnau Amddiffyn Plant Mudiad Meithrin. Rydym yn credu bod hapusrwydd, datblygiad a diogelwch pob plentyn yn hollol bwysig. Os oes rheswm i ni feddwl bod yna unrhyw amheuaeth o blentyn yn cael ei gamdrin bydd yr staff yn dweud wrth yr swyddogion amddifyn sef yr arweinydd Vicky Joseph. Os bydd amheuaeth o aelod o staff yn camdrin hysbysir i'r Person Gofrestredig. Mae'r staff yn mynychu hyfforddiant diogelu yn gyson.

Cylch Meithrin Talybont follow Mudiad Meithrin's Policy and Procedure for Safeguarding and Protection. We believe the happiness, development and safety of the children is paramount. If a member of staff suspects that a child is being abused then they will inform the Safeguarding Officer Vicky Joseph and the Registered Person will be informed. If there is a suspicion of child abuse by staff then the Registered Person should be informed and Child protection procedures will be followed. Staff attend child protection courses regularly.

Lleoliad

Lleolir y Cylch Meithrin yn y Tŷ Sbri, caban pwrpasol ar fuarth Ysgol Gymunedol Talybont. Mae'r Cylch Meithrin yn berchen ar yr adeilad a adeiladwyd yn 1997 drwy ymdrechion codi arian criw brwd o rhieni. Yn 2007 drwy ganiatad llywodreathwyr yr ysgol datblygwyd ardal allanol ar gyfer y Cylch. Mae yna lle o dan to i'r plant chwarae yn yr awyr agored, gyda llawer o adnoddau chwarae megis llithren, siglen ardal tywod, dwr, adeiladu, byd bach, beics, gegin fwd llawer mwy.

Amseroedd

Mae'r Cylch ar agor Dydd Llun i dydd Iau 8.15yb tan 15.15 yp yn ystod tymor yr ysgol. Mae'r Cylch yn cau yn ystod diwrnodau hyfforddiant mewn swydd yr ysgolion lleol. Yn achlysurol bydd y Cylch ar gau pan fydd hyfforddiant staff neu pan fydd staff yn mynychu cyrsiau. Rhoddir rhybudd o flaen llaw os fydd hyn yn digwydd. Petai rhaid cau's Cylch am unrhyw reswm arall fel tywyd gwael neu salwch staff byddwn yn ceisio cysylltu â rhieni cyn 8.00 y bore.

Mae pob plentyn yn cael cynnig llaeth am ddim yn y Cylch. Mae croeso i blant sy'n mynychu trwy'r dydd ddod â pecyn bwyd neu mae'r ysgol yn cynnig cinio a pwdin am £3.20 yn dyddiol.

Rydym nawr yn rhan o Dechrau Deg. Os ydych yn byw yn yr ardal Ceulanmaesmawr rydych yn gallu cael 12.5 awr o addysg wedi'i ariannu. Mae hwn yn dechrau pan y tymor ar ol i'ch plentyn troi yn 2. Gofynnwch am fwy o fanylion. Fydd e-bost ffioedd yn cael ei anfon pob hanner tymor. Fydd manylion ar sut i dalu ar yr ebost ac hefyd faint i dalu. Gallwch talu ar lein a fydd y manylion yma yn yr ebost hefyd. Trysorydd y cylch sydd yn casglu'r arian. Hyd yn oed os ydych plentyn yn absennol am unrhyw rheswm, salwch neu gwylliau, mae'n rhaid talu am le eich plentyn yn y cylch.

Os yw eich plentyn yn gadael y Cylch am unrhyw rheswm, gofynnir yn garedig am wythnos o rhybudd fel bod y pwyllgor yn cael amser i drefnu rhoi'r lle i blentyn arall.

Location

The Cylch is held in the Tŷ Sbri, which is a purpose built cabin within Talybont School yard. The Cylch Meithrin owns the building which was built in 1997 through the fund-raising efforts of a dedicated group of parents. There is a roofed balcony and safe enclosed outdoor play area directly accessible from the Caban equipped with a variety of activities. Activities include a slide, swings, water sand area, mud kitchen, bikes and small world play.

Times

The Cylch is open Monday to Thursday morning 8.15am to 3.15pm during school term time only. The Cylch is closed during the local schools INSET days. The term dates can be found on the Ceredigion County Council website. Occasionally the Cylch closes when staff attend courses. Notice will be given if this happens. If the Cylch must close due to unforeseen circumstances e.g severe weather or staff illness, we will try to contact all parents by 8am.

Please note that the Cylch closes at 3.15pm sharp. The staff are not paid after this time. The Cylch reserves the right to charge a penalty of £1 for every minute that a parent is late to collect a child.

Food

Children have the opportunity to eat a healthy snack together. Please pack a healthy snack for your child, we would suggest fruit, and a bottle of water. All children are offered free milk at the Cylch. Children who are staying all day are welcome to bring their own packed lunch or a hot school lunch is available for £3.20 per day which includes a main meal and dessert.

Please do not bring peanuts or products containing peanuts into the Cylch or school as there is a child with a nut allergy in the school.

Fees

Children 2-3 years old;

Morning session 8.15 - 12.00 £18

Afternoon session 12 - 3.15 £18

All day sessions 8.15 - 3.15 £35

Lunch is £3.20 per day.

For 3 years old there is 10 hours Government funding available. The funding is available following the term after their 3rd birthday. A 3 year old can attend four mornings for £18 a week. This is automatically applied when the child turns 3. Parents and guardians will need to sign a form.

We are now part of Flying Start. For children who live in the Ceulanmaesmawr area, we can offer 12.5 hours a week funding towards their attendance in the Cylch. This applies the term after their second birthday. Please ask for more details.

Fees are due every half term. Parents will receive an email which the calculated costs and information on how to pay online through BACS. Since covid 19 we do not accept cash. If your child is absent for any reason such as illness or holidays, full fees are still due.

Please give the Cylch one weeks notice if your child is leaving the Cylch. This enables the committee to arrange for your place to be given to another child.

Aelodau o Staff

Mae'r Cylch yn cael ei arwain gan Vicky Joseph sydd wedi derbyn cymhwyster NVQ Lefel 3 ac wedi mynychu hyfforddiant statudol Cymorth Cyntaf Pediatrig 12 awr, PREVENT, Hylendid Bwyd, Blynnyddoedd Rhyfeddol ac Amddiffyn Plant lefel 1, 2 a 3. Miss Hanna yw'r arweinydd prynhawn. Mae Miss Emily wedi derbyn cynhwyster NVQ Lefel 3, PREVENT, Cymorth Cyntaf Paediatric Lefel 3 ac Amddiffyn Plant lefel 2.

Mae'r pwyllgor yn gyfrifol am benodi a chyflogi staff y Cylch. Maent yn sicrhau bod pob aelod o staff a chymhwysterau perthnasol. Mae nhw'n annog pawb i fynychu hyfforddiant a chysiau perthnasol. Mae hwn yn cydymffurfio gyda gofynion Arolygaeth Gofal Cymru. Mae'r pwyllgor yn gwerthfawrogi unrhyw adborth am y staff.

Mae'r staff yn meddu ar gymhwysterau cymorth cyntaf, hylendid bwyd ac amddiffyn plant. Mynchau'r staff gysiau yn rheolaidd drwy'r Awdurdod Addysg Lleol a'r Mudiad Meithrin. Mae'r plant yn galw'r staff yn Miss Vicky, Miss Rachael, Miss Emily a Miss Violet.

Staff Members

The Cylch leader is Vicky Joseph who is NVQ level 3 qualified. Vicky has also completed her First Aid Paediatric course, PREVENT, Food Hygiene, Incredible Years and Child Protection levels 1,2 and 3.

Miss Emily is the afternoon leader and is qualified with NVQ level 3, Paediatric First Aid Level 3, PREVENT, Child Protection level 2 and Food hygiene level 2. All staff are Paediatric First Aid trained and have completed Food Hygiene courses, Safeguarding and PREVENT training. Staff are encouraged to attend training regularly through the local council or Mudiad Meithrin. Staff are all fully DBS checked.

Miss Vicky Joseph is the safeguarding officer.

The staff are known to the children as Miss Vicky, Miss Rachael, Miss Emily and Miss Violet.

The Cylch committee is responsible for recruiting and employing new members of staff. The committee ensures that the new staff have the relevant and necessary qualifications, and they encourage the staff to attend regular training. The Care Inspectorate of Wales standards are adhered to. The Committee appreciate any feedback regarding the staff.

Cofrestri

Mae'r Cylch wedi ei gofrestri i dderbyn 19 o blant, rhwng 2-4 oed gyda chymhareb o 1 oedolyn i 8 o blant 3 oed a 1 oedolyn i 4 plant 2 oed. Rydym yn medru derbyn plant sydd ag anghenion ychwanegol mewn cyd-weithrediad â chynllun cyfeirio y Mudiad.

Rydym yn derbyn archwiliad rheolaidd gan Arolygiaeth Gofal a Gwasanaethau Cymdeithasol Cymru (AGC). Rydym hefyd yn cael archwiliad gan ESTYN.

Registration

The Nursery is registered to accept 19 children between the ages 2-4 with a staff ratio of 1 adult to 8 children 3 years old and 1 adult to 4 children 2 years old. The Nursery accepts children with disabilities and co-works with Cynllun Cyfeirio through the Mudiad Meithrin to support the children with additional needs.

The Nursery has regular inspections from Estyn and Care Inspectorate Wales.

Iechyd a Diogelwch

Gofynnwn i rhieni rhoi manylion cyswllt i staff y Cylch ac i rhoi wybod yn syth os oes unrhyw newid.

Health and Safety

We kindly ask parents to inform us of any changes in their contact details as soon as possible including phones numbers, addresses, allergies and details of who is collecting their child from the nursery.

Salwch

Gofynnwn i rieni gadw eu plentyn o'r Cylch am 48 awr yn dilyn cyfnod o chwydu neu ddolur rhydd. Mae rhestr o glefydau heintus a'u cyfnod magu ar hysbysfwrdd y Cylch. Os oes plentyn yn sâl yn ystod sesiwn y cylch, byddwn yn cysylltu gyda rhiant neu gofalwr y plentyn yn syth ac yn gofyn iddynt dôd i gasglu'r plentyn.

Illness

If a child has sickness or diarrhoea we kindly remind parents to keep their child home from nursery for a minimum period of 48 hours since they were last ill. There is a list of various illnesses on the Nursery notice board listing the time scale a child needs to stay at home during a infectious illness. Please ask for more information if needed. If a child is ill during a Cylch session, we will contact the parents or guardian as soon as possible to collect the child.

Newid Cewynnau a Damweiniau

Fydd aelodau o'r staff yn newid cewynnau' plant ac fydd ffurflen I rhieni arwyddo i caniatu hwn. Os yw plentyn yn cael damwain, fe fydd staff yn newid y plentyn mewn i ddillad lan.

A member of staff will change the child's nappy. The parents/guardians will need sign a consent form for this. Staff will change a child into clean clothes if they have an accident.

Mae'r Cylch Meithrin yn rhan o Gynllun Cyn-ysgolion Iach a Chynaliadwy. Prif amcan y cynllun yw hyrwyddo iechyd a lles y plant, staff a theuluoedd drwy neud newidiadau yn y Cylch fydd yn dod yn rhan o fywyd dyddiol y lleoliad. Caiff gwaith ei neud o dan agweddau iechyd: Maethiad a Iechyd Y Geg, Gweithgarwch Corfforol/Chwarae Gweithdrefnol, Iechyd Meddwl ac

Emosiynol, Lles a Pherthnasol, Yr Amgylchedd, Diogelwch, Hylendid, Iechyd a Lles y Gweithle.

Healthy Preschool Scheme

We are part of the Healthy Preschool scheme. Our focus is to promote the health and well-being for the children, their families and the staff on a daily basis. This is achieved through different modules. Health of the mouth, Physical activities, Mindfulness and Emotional health, Well-being, Safety, Hygiene, Health and Well-being of the workplace.

Rydym yn rhoi'r profiadau a'r amgylchedd mewn ffordd holistaidd i sicrhau y cyfleoedd i'r plant i ddatblygu ei sgiliau o fewn ac ar draws y llwybrau dysgu. Y plentyn sydd yn y canol gyda'r pump llwybr dysgu sy'n cael ei cefnogi gan yr oedolion, yr amgylchedd, yr profiadau a'r addysgeg sy'n helpu nhw fod yn dysgwyr uchelgeisiol, cyfranwyr mentrus a chreadigol, dinasyddion egwyddorol a gwybodus a unigolion iach a hyderus.

We follow the non-maintained settings curriculum, which recognises that all children are individuals and will develop rapidly within the first five years of their life. There is a strong connection between the children and the principles of the child's learning as well as the four purposes. We offer holistic opportunities, experiences and real-life activities. Numeracy, literacy and digital competency are mandatory, and the five development pathways are also central to the curriculum.

Datblygiad

Rydym yn arsylwi ar y plant drwy gydol y sesiwn ac yn cofnodi camau datblygiad mewn cofnod cynnydd personol. Cedwir engreiffiau o waith y plant ac yn arddangos y gwaith tu fewn y Cylch. Ar ddiwedd y tymor gall plant fynd â'u waith adref. Rydym yn gwneud asesiadau Wellcomm i asesu iaith a llyferydd y plant.

Development

We observe the children throughout the session and record stages of development in a learning journal progress record. The children's work is displayed within the Nursery and all work is sent home at the end of each term. With the parents' permission, we do assess children's speech and language through the Wellcomm assessment.

Dillad

Gofynnwn i chi yn garedig i beidio wisgo eich plentyn yn ei ddillad orau. Byddant yn cael mynediad i ddeunyddiau celf ac yn defnyddio yr ardal allanol yn ddyddiol. Rydym yn awgrymu fod dillad sbâr yn ei bag ac esgidiau glaw a dillad glaw i wisgo tu allan. Mae'r plant yn cael cyfle i chwarae yn y gegin mwd, ar beics ac rydym yn annog y plant i cymryd rhan mewn chwarae anniben.

Clothing

We recommend that you not dress your child in their best clothes. They have access to art materials and use the outside area on a daily basis. We suggest that there are spare clothes in their bag and that they have wellies and rain-wear to wear outside. The children have the opportunity to play in the mud kitchen, on the Nursery's bikes and we encourage the children to take part in messy play.

Pwyllgor y Cylch Meithrin

Disgwylir rhieni i wasanaethu ar y pwyllgor ac i neud pob ymdrech i fod yn bresennol mewn cyfarfodydd. Rydym yn cynnal gweithgareddau i godi arian i'r Cylch yn ystod y flwyddyn. Mae'n cyfle da i rhieni ddod i adnabod rhieni eraill. Drwy godi arian i'r Cylch rydym yn medru cadw'r ffioedd y Cylch yn rhesymol fel bod pob plenty yn medru mynychu'r Cylch.

The Nursery Committee

The Nursery is managed by a committee of voluntary members, the nursery leader, the school headteacher, a member of the Ceulanmaesmawr Community Council, a representative of the Cylch Ti a Fi and all parents of the Cylch Meithrin children. Parents are expected to serve on the committee and to make every effort to attend meetings.

The Nursery relies solely on parents' fees, grants and fund-raising. We hold activities to raise money for the Cylch during the year. It is a good opportunity for parents to get to know other parents. By raising money for the Cylch we are able to keep the Cylch's fees reasonable so that all children can attend the Cylch.

Disgyblaeth ac Ymddygiad

Rydym yn hybu ymddygiad gadarnhaol mewn plant ac rhieni. Mae angen i blant fod yn medru chwarae a dysgu mewn amgylchedd hapus a thawel. Ceisiwn gyflawni hyn drwy:-

- Sicrhau hyfforddiant priodol i staff am ymddygiad plant
- Roi sylw gadarnhaol sy'n cynnwys canmoliaeth a gwobr i annog blant i chwarae gyda'i gilydd mewn modd priodol
- Ofyn i aelodau staff modelu ymddygiad cadarnhaol drwy trin pob plentyn a chydweithwyr gyda pharch a chwarteisi.
- Defnyddio strategaethau cadarnhaol i ddelio gyda unrhyw wrthdaro rhwng plant.

- Trin ymddygiad annerbyniol mewn ffordd sy'n addas ar gyfer yr oedran a datblygiad y plentyn drwy dynnu sylw, symud y plentyn o'r sefyllfa neu gynorthwyo'r plentyn i ddeall beth oedd yn bod a sut i ymdopi y tro nesaf.
- Esbonio pam bod eu gweithred yn amhriodol. Bydd y plentyn yn cael ei annog i ymddiheuro os yn briodol ac yn cael ei canmol am wneud hyn. Bydd y plentyn dderbyniodd gam yn cael ei gysuro.

Argyfwng/Emergencies

Mewn achos o argyfwng cysylltir gyda rhieni yn syth yn ol yr angen. Fyddwn yn gofyn yn rheolaidd i sicrhau bod manylion cyswllt yn gywir. Fydd unrhyw driniaeth feddygol yn cael ei gweithredu yn ol yr hyn a nodwyd gan rhieni ar y ffurlen gofrestru.

Bydd y Cylch Meithrin yn gweithredu o fewn terfynau rhesymol ac ymarferol, i sicrhau iechyd, diogelwch a lles y staff, y plant o dan ei ofal, myfyrwyr ar brofiad gwaith, gwirfoddolwyr ac ymwelwyr.

In the case of an emergency, parents will be contacted immediately. Parents are asked to check that their contact details are correct. Any medical treatment will be given as noted by parents on the registration form.

Please see the health, safety and welfare policy. The Cylch Meithrin will do everything it can, as far as possible to ensure the health welfare and safety of the children, staff, volunteers and visitors.

Discipline and Behaviour

We promote positive behaviour in children and parents. Children need to be able to play and learn in a happy and calm environment. We seek to achieve this by:-

- Ensuring appropriate training for staff about children's behaviour.
- Give positive attention that includes praise and reward to encourage children to play together in an appropriate manner.
- Ask staff to model positive behaviour by treating all children and colleagues with respect and courtesy.
- Use positive strategies to deal with any conflict between children.

- Treat unacceptable behaviour in a way that suits the child's age and development by distracting, removing the child from the situation or helping the child to understand what was wrong and how to cope next time.
- Explain why their action was inappropriate. The child will be encouraged to apologise if appropriate and praised for doing this. The child who was hurt or upset will be comforted.
